5-Year Strategic Committee Plan Report

2/21/2024

- 1.) The mini-dump truck and tractor will be purchased soon. We spread the payments out over four years. With these two loans and the roller, total loan payments per year are around \$65K to service all the equipment debt. This is very affordable for the town due to CHIPS funding generally coming in around \$165K per year.
- 2.) Soon, we will go back through a full examination of Capital Improvement and Highway Equipment needs. However, we have done very well over the last few years with very little remaining to be planned for in the foreseeable future. Perhaps the replacement of the grader would be next to be considered if we think its useful life is less than five years.
- 3.) The focus will now shift to the other points of the strategic plan. Namely,
 - a. Web page updates. I have provided an initial review of our existing web page.
 - b. Community outreach and events.
 - c. Quarterly newsletter to the residents.

New committee members are needed to help drive this portion of the plan and the plan will need to be documented in a formal plan per new requirements.
